Here one more example is concerning peace i.e., In the event of the conquest of Makkah Hadrat Muhammad (PBUH) had given protection to all in the shade of peace without the difference of caste, color, and creed. Although in front ofHadrat Muhammad (PBUH) was his mortal enemies and the killers of his uncle Hamza (RA), but he forgave them all, there is no greater example of peace in history. 13 Similarly, when Hazrat Abu Bakr (RA) was sending Hazrat Usama (RA) to the boundaries of Syria for taking revenge of martyrs of Mutha, Abu Bakr (RA) advised to Usama's army before the departure that people stop!I advise you concerning ten things to remember them, do not betray, do not hide wealth, do not be unfaithful with your army, do not cut off anyone's limbs, do not kill old men, children, and women, do not cut down palm and fruit trees. Do not slaughter animals for any purpose other than eating. You will find people who have left the worldly life and are sitting in monasteries in worship. Do not harm them.¹⁴Likewise, many instances are present in history about to create peace in society. On an occasion, Hadrat Muhmmad (PBUH) advises to human beings that "He who does not have mercy on people, Allah will not be kind to him". 15

Qur $\bar{\alpha}$ n says that; "Do good and kindness to others as Allah does good to you". 16

Islam is a religion of mercy; its love encompasses all humanity. Islam has strongly urged its followers to deal with other nations and religions with equality, compassion, and tolerance.

3.3. The Situation of Contemporary Society
